# Dorset Council (Parts of Footpaths 79 and 92, Weymouth at Curtis Fields) Public Path Diversion Order 2022

This Order is made by Dorset Council ("the authority") under section 257 of the Town and Country Planning Act 1990 ("the 1990 Act") because it is satisfied that it is necessary to divert the footpaths to which this Order relates in order to enable development to be carried out in accordance with planning permission granted under Part III of the Town and Country Planning Act 1990 namely: the development of approximately 500 residential dwellings in 3 phases (phases 2 to 4) at Curtis Fields land south of, Chickerell Road, Weymouth.

This Order is also made under section 53A(2) of the Wildlife and Countryside Act 1981 ("the 1981 Act") because it appears to the authority that the County of Dorset definitive map and statement require modification in consequence of the occurrence of an event specified in section 53(3)(a)(i) of the 1981 Act, namely, the diversion (as authorised by this Order) of a highway hitherto shown or required to be shown in the map and statement.

### **BY THIS ORDER:**

- 1. The footpaths over the land shown by bold black lines on the attached map and described in Part 1 of the Schedule to this Order ("the Schedule") shall be diverted and the County of Dorset definitive map and statement shall be modified as provided below.
- 2. There shall be created to the reasonable satisfaction of Dorset Council alternative highways for use as a replacement for the said footpaths as provided in Part 2 of the Schedule and shown by bold black dashes on the attached map.
- 3. The diversion of the footpaths shall have effect on the date on which Dorset Council certify that the terms of Article 2 above have been complied with, and upon the occurrence of that diversion the County of Dorset definitive map shall be modified by deleting from it the paths or ways referred to in Article 1 of this Order and the paths or ways referred to in Article 2 of this Order shall be added to it, and the definitive statement shall be modified as described in Part 3 of the Schedule.
- 4. The following works shall be carried out in relation to the highway described in Part 2 of the Schedule:

Construction of tarmac paths with a width of 2 metres between points A (SY 6643 7828) E (SY 6645 7829), F (SY 6651 7836), G (SY 66671 78495), H

(SY 66673 78494) I (SY 66677 78506) and C (SY 66677 78508) and between points D (SY 6633 7838), J (SY 66348 78379) and E (SY 6645 7829).

- 5. Betterment Properties Ltd is hereby required to pay for the cost of carrying out the said works.
- 6. Where immediately before the date on which the footpaths are diverted there is apparatus under, in, on, over, along or across it belonging to statutory undertakers for the purpose of carrying out their undertaking, the undertakers shall continue to have the same rights in respect of the apparatus as they then had.

# <u>Part 1</u>

### Description of site of existing paths

Part of Footpath 79, Weymouth:

A – B – C The full width of the footpath from the unaffected part of Footpath 79 at point A (SY 6643 7828) generally north east to point B (SY 6652 7836) and then continuing north east to point C (SY 66677 78508) to its junction with Markham Avenue.

Part of Footpath 92, Weymouth:

D – B The full width of the footpath from the unaffected part of Footpath 92 at point D (SY 6633 7838) generally east south east to its junction with Footpath 79, Weymouth at point B (SY 6652 7836).

## Part 2

### Description of site of alternative highways

Part of Footpath 79, Weymouth:

- A E F From the unaffected part of Footpath 79 at point A (SY 6643 7828) north east
- -G-Halong a tarmac surface to its junction with the proposed new route of Footpath 92 at point E (SY 6645 7829). Then south east, north east and generally north to point F (SY 6651 7836), then generally north east and north north east to point G (SY 66671 78495). Continuing east south east to point H (SY 66673 78494), north north east to point I (SY 66677 78506) and north north west to Markham Avenue at point C (SY 66677 78508) to its junction with the unaffected part of Footpath 79. The width of this part of Footpath 79 is 2 metres.

Part of Footpath 92, Weymouth:

D – J – E From the unaffected part of Footpath 92 at point D (SY 6633 7838) south east along a tarmac surface to point J (SY 66348 78379) and then east south east and generally south east to its junction with the proposed new route of Footpath 79 at point E (SY 6645 7829). The width of this part of Footpath 92 is 2 metres.

Lanehouse Rocks Road along Cockles Lane eastwards to SY 6633 7838 south east along a tarmac surface to SY 66348 78379 and then east south east and generally south east to its junction with Footpath 79 at SY 6645 7829. Width: 2 metres between SY 6633 7838 and SY 6645 7829.
