**Dorset Council (Footpaths 2 & 5 Symondsburry, Footpaths 98, 99 (Part), 100,  
101 (Parts), 102 (Part) & 108 (Part), Bridport at Vearse Farm / Foundry Lea)  
Public Path Diversion Order 2025**

This Order is made by Dorset Council ("the authority") under section 257 of the Town and Country Planning Act 1990 ("the 1990 Act") because it is satisfied that it is necessary to divert the footpaths to which this Order relates in order to enable development to be carried out in accordance with planning permission granted under Part III of the Town and Country Planning Act 1990 namely: the construction of 760 dwellings, public open space (including play space and landscape planting), allotments, an orchard, sports pitch provision, with associated changing rooms and car parking, pedestrian, cycle and vehicular links, drainage works and associated infrastructure (WD/D/17/000986 and P/RES/2021/04848)

This Order is also made under section 53A(2) of the Wildlife and Countryside Act 1981 ("the 1981 Act") because it appears to the authority that the County of Dorset definitive map and statement require modification in consequence of the occurrence of an event specified in section 53(3)(a)(i) of the 1981 Act, namely, the diversion (as authorised by this Order) of a highway hitherto shown or required to be shown in the map and statement.

**BY THIS ORDER:**

1. The footpaths over the land shown by bold black lines on the attached map and described in Part 1 of the Schedule to this Order ("the Schedule") shall be diverted and the County of Dorset definitive map and statement shall be modified as provided below.
2. There shall be created to the reasonable satisfaction of Dorset Council alternative highways for use as a replacement for the said footpaths as provided in Part 2 of the Schedule and shown by bold black dashes on the attached map.
3. The diversion of the footpaths shall have effect on the date on which Dorset Council certify that the terms of Article 2 above have been complied with and upon the occurrence of that diversion the County of Dorset definitive map shall be modified by deleting from it the paths referred to in Article 1 of this Order and the paths referred to in Article 2 of this Order shall be added to it, and the definitive statement shall be modified as described in Part 3 of the Schedule.
4. The following works shall be carried out in relation to the highway described in Part 2 of the Schedule; namely the provision of:

- (i) A footpath 2 metres wide with a grass surface between points A7 & A2
- (ii) A footpath 2 metres wide with a grass surface between points U & A5
- (iii) A footpath 2 metres wide with a grass surface between points L & P
- (iv) A footpath 2 metres wide with a grass surface between points T & A6
- (v) A footpath 2 metres wide with a grass surface between points Q & S, with a culvert at point Q and removal of a field gate between points R & RR
- (vi) A footpath 2 metres wide with a paved/tarmac surface between points LL & KK
- (vii) A footpath 2 metres wide with a paved/tarmac surface between points A3 & QQ and a grass surface between QQ & O
- (viii) A footpath 2 metres wide with a paved/tarmac surface between points A2 & A3
- (ix) A footpath 2 metres wide with a paved/tarmac surface between points C-MM-D
- (x) A footpath 2 metres wide with a paved/tarmac surface between points GG & JJ
- (xi) A footpath 2 metres wide with a grass surface between points A5 & V and a paved / tarmac surface between points V & H
- (xii) A footpath 2 metres wide with a paved/tarmac surface between points J & Z
- (xiii) A footpath 2 metres wide with a grass surface between points FF & HH
- (xiv) A footpath 2 metres wide with a grass surface between points EE & II
- (xv) A footpath 2 metres wide with a grass surface between points A6 & W and a paved/tarmac surface between points W & BB

5. Barratt David Wilson Homes and Countryside Partnerships are hereby required to pay for the cost of carrying out the said works.

6. Where immediately before the date on which the footpaths are diverted there is apparatus under, in, on, over, along or across it belonging to statutory undertakers for the purpose of carrying out their undertaking, the undertakers shall continue to have the same rights in respect of the apparatus as they then had.

## SCHEDULE

A – A1 The whole width of the footpath from its junction with West Road (B3162) at Point A (SY 45326 93099) south east and south south east to its junction with Footpath 98, Bridport and the parish boundary at point A1 (SY 4543 9300). (No recorded width)

##### Footpath 5, Symondsburly

G – A4 The whole width of the footpath from its junction with Broad Lane (C91) at point G (SY 45742 92175), north north west to its junction with Footpath 101, Bridport and the parish boundary at point A4 (SY 4566 9236). (No recorded width)

##### Footpath 98, Bridport

A1 – B The whole width of the footpath from its junction with Footpath 2, Symondsburly and the parish boundary at point A1 (SY 4543 9300) south east to its junction with Footpaths 99 and 100, Bridport at point B (SY 4550 9278). (No recorded width)

##### Footpath 99, Bridport

C – B – D The whole width of the footpath from the unaffected part of Footpath 99, Bridport north of Vearse Farm at point C (SY 4550 9264) north via its junction with Footpaths 98 and 100, Bridport at point B (SY 4550 9278) to the unaffected part of Footpath 99, Bridport at point D (SY 4551 9294), south of the river Simene and parish boundary. (No recorded width)

##### Footpath 100, Bridport

B – E – F The whole width of the footpath from its junction with Footpaths 98 & 99, Bridport at point B (SY 4550 9278), south east then east north east and north east to point E (SY 4592 9287) and north east to its junction with Footpath 108, Bridport at point F (SY 45933 92884). (No recorded width)

##### Footpath 101, Bridport (two parts)

A4 – H The whole width of the footpath from its junction with Footpath 5, Symondsburly and the parish boundary at point A4 (SY 4566 9236) generally north east to the unaffected part of Footpath 101, Bridport at its junction with Footpath 102, Bridport at point H (SY 4577 9259)

and and

I – E – F The whole width of the footpath from the unaffected part of Footpath 101, Bridport at point I (SY 4584 9275) generally north east to its junction with Footpath 100, Bridport at point E (SY 4592 9287) and north east to its junction with Footpath 108, Bridport at point F (SY 45933 92884). (No recorded width)

#### Footpath 102, Bridport

J – H The whole width of the footpath from the unaffected part of Footpath 102 at point J (SY 4553 9244) south east of Vearse Farm generally east north east then north east to its junction with Footpath 101 at point H (SY 4577 9259). (No recorded width)

#### Footpath 108, Bridport

K – HH The whole width of the footpath from its junction with Footpath 45, Bridport and Magdalene Lane (D12830) at point K (SY 4596 9285) north west to the unaffected part of Footpath 108, Bridport at point HH (SY 45935 92883) south of the river Simene and parish boundary. (No recorded width)

#### Footpath 2, Symondsburry

A7 – L – A2 From its junction with West Road (B3162) at Point A7 (SY 45313 93095) generally south west for approximately 10 metres to its junction with the proposed new Footpath 96, Symondsburry at point L (SY 4531 9308) and then generally south south east and south east through a grass field to its junction with the proposed new route of Footpath 98, Bridport and the parish boundary at point A2 (SY 4538 9296). Width: 2 metres

#### Footpath 5, Symondsburry

U – RR – A5 From its junction with Broad Lane (C91) at point U (SY 45747 92176), north west through a grass field for approximately 7 metres to its junction with the proposed new Footpath 98, Symondsburry at point RR (SY 4574 9218) then north west to its junction with the proposed new route of Footpath 101, Bridport and the parish boundary at point A5 (SY 4568 9237). Width: 2 metres

#### Footpath 96, Symondsburry (new footpath)

L – M – N  
– O – P From its junction with the proposed new route of Footpath 2, Symondsburry at point L (SY 4531 9308), through grass fields, generally west then south west to point M (SY 4485 9298) then generally south and south east to point N (SY 4497 9286) then generally south west and south east and south south east to its junction with the proposed new Footpath 100, Symondsburry at point O (SY 4510 9258) then continuing generally south south east to its junction with Footpath 7, Symondsburry at point P (SY 4518 9241). Width: 2 metres

#### Footpath 97, Symondsburry (new footpath)

T – S – A6 From its junction with Skilling Hill Rd (C91) at point T (SY 4582 9218) north north west through a grass field for approximately 8 metres via its junction with the proposed new Footpath 98, Symondsburry at point S (SY 4581 9219) and then north north west to its junction with the proposed new Footpath 118, Bridport and the parish boundary at point A6 (SY 4576 9239). Width: 2 metres

#### Footpath 98, Symondsburry (new footpath)

Q – R – RR – S From its junction with Footpath 3, Symondsburry at point Q (SY 4523 9226) through a grass field generally south east then south south east to point R (SY 4528 9213) then generally east north east via its junction with the proposed new route of Footpath 5, Symondsburry at point RR (SY 4574 9218)

to its junction with the proposed new Footpath 97, Symondsburry at point S (SY 4581 9219). Width: 2 metres

Footpath 99, Symondsburry (new footpath)

LL – KK From its junction with Footpath 103, Bridport and Footpath 7, Symondsburry at point LL (SY 4538 9256), north north west for approximately 4 metres, north west for approximately 6 metres, north north east for approximately 20 metres, then north north west for approximately 68 metres along a paved / tarmac surface to its junction with the new Footpath 100, Symondsburry at point KK (SY 4536 9265). Width: 2 metres

Footpath 100, Symondsburry (new footpath)

A3 – KK – From its junction with the new Footpath 98, Bridport and the parish boundary at point A3 (SY 4537 9265) west south west for approximately 10 metres along a paved / tarmac surface to its junction with the proposed new Footpath 99, Symondsburry at point KK (SY 4536 9265) then continuing generally south west to point QQ (SY 4513 9259) then south west through a grass field for approximately 29 metres to its junction with the new Footpath 96, Symondsburry at point O (SY 4510 9258). Width: 2 metres

Footpath 98, Bridport

A2 – II – From its junction with the proposed new route of Footpath 2, Symondsburry and the parish boundary at point A2 (SY 4538 9296), south east along a paved / tarmac surface for approximately 6 metres to point II (SY 4539 9296) continuing generally south east, south and south south west to its junction with the proposed new route of Footpath 100, Bridport at point JJ (SY 4540 9276), south east for approximately 2 metres then generally south west, south south east, south south west, south east, south west, north west and west south west to its junction with the proposed new Footpath 100, Symondsburry and the parish boundary at point A3 (SY 4537 9265). Width: 2 metres

Footpath 99, Bridport

C – MM – From the unaffected part of Footpath 99, north of Vearse Farm at point C (SY 4550 9264), generally north north east for approximately 20 metres then north to its junction with Footpath 100 at point MM (SY 4551 9275) then continuing generally north for approximately 192 metres then north west for approximately 7 metres then north to join the unaffected part of Footpath 99 at point D (SY 4551 9294), south of the river Simene and parish boundary. Width: 2 metres

proposed new Footpath 117, Bridport at point EE (SY 45931 92861), then  
east north east via its junction with the proposed new Footpath 108, Bridport  
at point FF (SY 45936 92863) to its junction with Magdalene Lane (D12830)  
at point GG (SY 4596 9287). Width: 2 metres

#### Footpath 101, Bridport

A5 – V – From its junction with the proposed new Footpath 5, Symondsburry and the parish boundary at point A5 (SY 4568 9237) north north west through a grass field for approximately 14 metres then north east for approximately 17 metres to point V (SY 4569 9239) then along a paved / tarmac surface generally north for approximately 19 metres, north north east for approximately 8 metres, generally north east for approximately 32 metres, north west for approximately 5 metres and generally north north east for approximately 60 metres to its junction with the proposed new route of Footpath 102, Bridport at point Z (SY 4573 9250) then generally north north east and north east for approximately 56 metres to point AA (SY 4575 9255) then north north east for approximately 34 metres to its junction with the proposed new Footpath 118 at point BB (SY 45769 92583), north north west for approximately 5 metres to point CC (SY 45767 92588) and north east for approximately 12 metres to the existing unaffected part of Footpath 101 at point H (SY 4577 9259). Width: 2 metres

#### Footpath 102, Bridport

– Z From the unaffected part of Footpath 102 to the south east of Vearse Farm at point J (SY 4553 9244), south south east along a paved / tarmac surface for approximately 5 metres, south east for approximately 9 metres, south south east for approximately 33 metres to point X (SY 4555 9240), then continuing east north east for approximately 21 metres, north north west for approximately 13 metres, east north east for approximately 9 metres, north north west for approximately 8 metres, and then generally north east and north north east to point Y (SY 4569 9251) and east south east for approximately 42 metres to its junction with the proposed new route of Footpath 101 at point Z (SY 4573 9250). Width: 2 metres

#### Footpath 108, Bridport

FF – HH From its junction with the new route of Footpath 100 at point FF (SY 45936 92863) generally north through a grass field for approximately 20 metres to its junction with the existing route of Footpath 108, Bridport at point HH (SY 45935 92883). Width: 2 metres




